### Watson Grinding Explosion in Houston

On January 24, 2020, a massive explosion ripped through the Watson Grinding and Manufacturing facility in northwest Houston. The blast damaged 450 structures in the area surrounding the facility. MWL's Texas office heard the news a few hours after the explosion and took immediate action on behalf of its clients and retained a fire and explosion team of experts to begin investigation into the root cause of the explosion. MWL will be at the forefront of the investigation actively pursuing subrogation recoveries on behalf of our clients who pay out losses to their insureds as a result of this explosion. A truck driver, while making a delivery to a company in north central Wisconsin, slipped and fell on their ice-covered lot causing injury to his left hip resulting in surgery and complications. The company initially denied the claim based upon their ice and snow removal efforts under the conditions as well as the claim of contributory negligence on the driver's part. The driver wasn't represented but we were able to pursue the case for the carrier to encompass all damages.
